



Ordinary Membership

\$ 165.00 (Ex. GST)

Ordinary membership is available to individuals, companies and organizations actively involved in grape growing or winemaking within the Grampians GIC region.

Ordinary membership entitles full voting rights of one vote per membership.

Associate Membership

\$110.00 (Ex. GST)

Associate membership is available to individuals, companies or organizations not actively involved in grape growing or winemaking but having a direct interest in the industry such as industry suppliers, restaurants, accommodation, educational institutions or wine and grape businesses (e.g. wine wholesaler/retailers and grape vine nursery and viticultural suppliers).

Marketing Levy

The marketing levy is available to all members who grow grapes and or make and sell wine. Any marketing member must also be an ordinary member.

Payment of the marketing levy entitles members to the following:

- a) Inclusion in collective marketing which involves GWI.
- b) Subsidised participation in collective marketing.
- c) Subsidised participation in events.
- d) Inclusion in presentation of local wines at events such as Longest Lunch and other Grampians Winemakers Inc. promotional activities.

Participation in some marketing activities, such as Great Grape Route brochure, may be determined by the conditions stipulated by wine industry bodies such as VWIA, VWTC and Tourism Victoria.

Non market levy paying members wishing to be involved in selected activities, such as specific brochure advertising will be required to pay the full proportional share of the cost and subject to approval of application by the Grampians Winemakers Inc. marketing sub-committee.

Full Marketing Levy

\$ 800 (Ex. GST) * plus wine donation

Applicable to vignerons producing 2250 litres or more of wine and selling this wine either at a cellar door, by mail order, via the internet, wholesale or direct to the retail trade.

* A contribution of one dozen 750 ml bottles of wine to be donated for promotional purposes at the discretion of the Grampians Winemakers Inc. Marketing sub-committee.

Reduced Marketing Levy

\$ 400 (Ex. GST) * plus wine donation
